If your business requires the services of **certification** bodies, **testing** or **calibration** laboratories, or **inspection** bodies then using a UKAS-accredited supplier for these evaluation services (also known as conformity assessment services) can save both time and money.

An evaluation body accredited by UKAS has proved that it complies with best practice and is competent to deliver a consistently reliable, impartial and accurate service which meets the appropriate, internationally-recognised standard.

By choosing a UKAS-accredited supplier, not only can you be assured that you are receiving the **most appropriate service for your needs** but you will also discover that the UKAS 'symbol' on your documentation brings with it **national and international recognition** to your business.

Together, these attributes will:

- **reduce paperwork and increase efficiency** by reducing the necessity to re-audit your business or re-test your products for new markets;
- **de-risk your procurement** by taking the guesswork out of choosing an evaluation body and by giving you confidence that you will get the service that best fulfils your requirements;

CERTIFICATION

You may spend considerable time, effort and resource in the certification process because you have been persuaded of its importance as a business tool and because of the business benefits it can bring.

But unless you have used a UKAS-accredited certification body, the benefits of certification could fall short of your expectations.

Prospective customers may be unsure of the credibility of your certification and you may find yourself suffering from internal inefficiencies because your management systems have not been identified as inappropriate to your needs.

In the UK, UKAS accredits around 150 certification bodies, ranging from small specialists to large, internationally-recognised organisations employing many hundreds of people. You can be sure that **one of these UKAS-accredited certification bodies will have the right people, technical expertise, management systems and track record to competently audit and certify your business.**

Types of certification that are accredited

While **Quality Management System** certification (to ISO 9001) accounts for a large proportion of work undertaken by certification bodies, there are other equally important areas of work, namely:

- **Product** Certification
- **Personnel** Certification
- Certification of **Information Security Management Systems**
- Certification of **Environmental Management Systems**
- Certification of **IT Service Management Systems**
- Certification of **Food Safety Management Systems**
- Certification of **Occupational Health and Safety Management Systems**
- Certification of **Business Continuity Management Systems**

Many UKAS-accredited certification bodies work in several or all of these areas, others may specialise in just one.





INSPECTION

Typically, inspections will cover product design, products, materials and equipment, installations, plant, processes and services.

Some of these areas will be covered by legislation that demands that regular inspection is undertaken.

The competence of any inspection body you appoint may be crucial in maintaining your reputation as a responsible organisation. You will want to make sure that the organisation you pay to undertake inspections on your behalf has the people, facilities, technical expertise, management systems and track record to undertake the inspection professionally and competently.

Rather than leave your reputation to chance, **ensure** that your inspection body is competent by using one that has been accredited by UKAS. By doing so, you can be sure that you have invested your money wisely and have taken the necessary steps to manage and minimise your risks.

What to look for

The internationally-recognised standard for the competence of inspection bodies is **ISO/IEC 17020:2012**. It is **the** standard against which UKAS accredits inspection bodies.

ISO/IEC 17020 should not be confused with the quality management standard ISO 9001:2008 which is specific to quality management systems. ISO 9001:2008 does not require evaluation of the technical competence of an inspection body and should not be regarded as an 'acceptable' alternative to ISO/IEC 17020.

There are well over 250 UKAS-accredited inspection bodies in the UK. Whatever your inspection needs there is more than likely an inspection body qualified to do the job.



Many tenders for supplying into Government departments or blue-chip companies require that a business has had its management system certified by an organisation accredited by UKAS.

There are alternatives to accredited certification, however there are dangers associated with choosing these routes that businesses need to consider. The integrity of a business' management system, and ultimately the products and services that it provides, can be seen through its certificate. An accredited certificate provides that confidence of integrity. A non-accredited certificate cannot give that confidence as it does not have the advantage of being underpinned by a third party accreditation body such as UKAS. Consequently it does not have the credibility or acceptability within the marketplace."

“Our supplier selection policy stipulates that a business must demonstrate financial viability, Health & Safety competence, and UKAS accreditation. As a purchaser, it is essential that we get what we ask for.

UKAS accreditation is a pre-requisite whenever we are choosing an organisation to work with to help us manage asbestos. We do not however look for UKAS accreditation in one area of asbestos management. We would look for it in all areas – for example for testing, surveying and air testing.

The reasons for using a UKAS-accredited company are manifold. Firstly, it is a way of ensuring the quality of the work. However it is not just about the quality, as we are dealing with the management of asbestos in schools and offices, and so there are clearly reputational issues at stake as well.

Using a UKAS accredited organisation is not going to necessarily increase the price of procuring a particular service. A UKAS-accredited organisation will offer value for money. The cost of getting it wrong and re-working is phenomenally expensive. This would not be the best use of rate payers’ money. It is much cheaper to get it right first time.”

TESTING and CALIBRATION

Testing is used to demonstrate the meeting of a specification. This may be a customer requirement or legal obligation or part of your own product development regime.

You need to be absolutely **sure** that the laboratory carrying out your testing for you has the people, facilities and track record to produce valid and accurate data and results each and every time. The same applies to any laboratory carrying out calibrations on your behalf.

What to look for

The internationally-recognised standard for the competence of laboratories is **ISO/IEC 17025:2005**. A laboratory accredited by UKAS to this standard has the competence, impartiality and performance capability that ensures you will receive the service that meets your needs.

Accreditation to this standard also means a laboratory’s management systems meet the principles of ISO 9001:2008—a fact endorsed by three international organisations: the International Organisation for Standardisation (ISO), the International Laboratory Accreditation Cooperation (ILAC) and the International Accreditation Forum (IAF). A laboratory certified to ISO 9001:2008 but *without* ISO/IEC 17025 should *not* be considered a suitable alternative.

UKAS accredits around 1500 facilities to carry out testing and calibration. There will be one that can do the right job for you.



Make an informed choice and have confidence in your suppliers – look for the UKAS symbol

A UKAS-accredited body is permitted to display one of the National Accreditation symbols illustrated here as proof of accreditation. They are the symbols you should look for as positive proof of competence. They allow you to make an informed choice.
