

## Timeline for Transition of Accreditation to HSG 248 Asbestos: The Analysts' Guide

## Timeline

Following the first publication of HSG248 in May, Laboratories have had around a 2-month window to-date, to absorb and begin to consolidate the changes in their technical activities within their supporting management system.

Following input from various technical sources and implementation of the process, whereby a number of laboratories have trialled the proposed mechanism, UKAS has been able to verify the effectiveness of the approach.

As of the 1st September, (and not before) Laboratories will be able to submit their declarations to UKAS, with supporting evidence. It is acknowledged that due to the varying scopes retained by laboratories, the time needed to complete this process will affect some laboratories more than others. Therefore, a second scheduled 'window' of 3 months will, in effect, provide up to 6 months for a laboratory (say, with a complex scope and multi-site) to conduct a full gap analysis, implement the required changes, as well as submit suitable evidence of implementing those change(s) where applicable.

Declarations will not be accepted before the 31st August. This is to encourage a timely process of implementation within laboratories, primarily to develop their gap analysis.

Likewise, to ensure the process remains effective, UKAS will only guarantee appropriate review and feedback to those laboratories who submit their initial declaration and evidence before the 1st December. Where customers do not submit their initial Declaration<sup>+</sup> (Doc D) by this time, UKAS cannot guarantee that their testing accreditation will be recognised by the 1st February 2022.

Whilst follow-up submissions of the Declarations may be received by UKAS after 1st Dec, any customers with declaration reviews not completed by the 1st February may face sanctions, as ed1 of HSG 248 will no longer be recognised for accreditation purposes beyond this date. Therefore, it is in the interests of all laboratories to implement the requirements in a timely manner and submit their declarations as early as possible after the 1st September.

From the 1st December onwards UKAS will continue the process of review and feedback to laboratories.

As of 1st Feb: there will be formal recognition of HSG248 Second Edition.

**NOTE:** Formal recognition will be dependent on any associated invoices being cleared by the Laboratory.

**NOTE:** Evidence to be submitted is, 'where relevant'

## New applicants/existing laboratories

For new applicants or existing laboratories who subsequently apply for accreditation as an extension in any of the affected tests, they will be assessed to the revised Guidance. There is no perceived commercial advantage to applications of this nature during this period, compared to those labs going through the transition process, as the timeline for new applications and extensions to scope, are observed to be of a similar duration to that as being prescribed for the transition itself. Furthermore, new applicants may also not have the benefit of the required infrastructure and supporting processes that are currently demonstrated by existing accredited laboratories.
