<p>Core responsibilities</p>	<p>Establish and maintain relationships with key stakeholders in relation to accreditation (in both Operations and Development) to enable effective and efficient co-operation such that assessment services can be delivered in accordance with stakeholder requirements.</p> <p>Monitor and evaluate the implementation of accreditation requirements by UKAS, to further develop and improve management and implementation.</p> <p>Monitor changes to UKAS requirements, legislation, etc. and work with stakeholders and the sector to ensure that accreditation remains appropriate.</p> <p>Working with UKAS TQR ensure the technical operational activities are satisfactorily delivered including co-ordination and management of TACs, and selection, development and management of relevant TFPs.</p> <p>With relevant input from stakeholders, develop and maintain any specific UKAS policy and process documentation such that it is up-to-date, appropriately controlled (normally within the UKAS management system) and effectively communicated to staff and assessors as required.</p> <p>With respect to development projects, communicate and cooperate, as necessary, with the Development section to facilitate the effective and efficient delivery and subsequent transfer to Operations of development projects.</p> <p>In Support of the Section Head</p> <ul style="list-style-type: none"> + To provide support to the relevant Section Head in co-ordinating and monitoring the work of the accreditation section, including authorising accreditation decisions and contract reviews. This may include (but not be limited to) the following aspects of work that fall within the overall responsibility of the Section Head: + Effectively manage and develop, through use of performance management, Assessment Managers such that they are effective and efficient in the delivery of accreditation services. + Assist the Section Head in the utilisation of quality, operational and financial KPIs such that the section achieves and maintains acceptable performance and strives to continually improve. + Authorise contract reviews and provisional and final decisions to determine compliance with UKAS policy and procedure and authorise/question as necessary. + Investigate complaints or appeals as requested in order to make a recommendation on the action required or take such action as is required to resolve such complaints.

	<ul style="list-style-type: none"> + Collect and utilise market intelligence from the field force to enable the identification of new business opportunities and development of existing business activities. + Assist in the recruitment and training of new Assessors and Assessment Managers. + Undertake internal audit duties as required by the UKAS Quality Manager in order to enable UKAS to meet its quality system requirements. + Respond to technical enquiries as appropriate including supporting the work of the other sections of the organisation. + Assist in the provision of appropriate technical accreditation training, mentoring and monitoring of new Assessment Managers to provide experienced guidance in the workings of the accreditation process. + Monitor the performance of Assessment Managers and assessors to ensure they are meeting performance requirements and conducting their work in accordance with internal policies and procedures and relevant international standards, identifying and addressing any training needs. + Review on a continuing basis the technical assessor resource required by the company.
